







1. That **Mata Risalo Devi Charitable Trust** (Name of the Society Trust/ Company under section B) is a registered Society/Trust under the Indian Trust Act 1882 (Name of the Act under which society/trust is registered/Section)
2. That the **Mata Risalo Devi Charitable Trust** (Name of the Society/Trust/Company under section 8) is of Non-Proprietary Character.
3. That the school is being run as a community service and not as a business and commercialization does not take place in the school in any manner whatsoever.
4. That no part of income from the Institution is being and will be diverted to any individual in the Trust/Society/Company/School Management Committee or to any other person/entity The saving if any after meeting the recurring and Non- recurring expenditure and contributions to developmental, Depreciation contingency fund will be further utilized for promoting the School and extending the cause of education in the same school only.

6. That the school will not open classes under CBSE pattern particularly class IX/X/X/XII and will not use CBSE name in any manner affiliation without obtaining.
7. That the Principal and Correspondent/Manager of the school have individually gone through the provisions contained in the affiliation and examination byelaws and the circulars issued by the Board from time to time. The school undertakes to abide by the provision contained in the affiliation and examination byelaws, directions issued from time to time and the law of the land.
8. That the school will ensure compliance of all statutory requirements like EPF, ESI and Labour Laws etc. with respect to the school and staff of the school.
9. That the school will ensure that the Building Safety, Fire Safety, Water Safety, Health and Hygiene certificates are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed term.




